**Update from Snoqualmie Valley Community Network**

SVCN summer food plans for the lower valley

- Partners are joining forces to offer grab and go lunches 5 days a week and power packs on the weekends
- Holy Innocents Church Food Pantry, Tolt UCC Church, Snoqualmie Valley Community Network, Hopelink, Duvall and Carnation libraries

**Update about Eviction Protections**

- Eviction protections have been extended to Aug 1<sup>st</sup> with some modifications
- A requirement - spend 14 day stay in a hotel – cannot spend one night in a motel and qualify for eviction protections

**Update from Snoqualmie Valley Food Bank**

- Summer Food Program
- A weeks' worth of food at a time including weekend
- Asking families for minimal information: Family name, school and zip code (maybe provide school name – unsure about this)
- The menu is put together and is for 10 weeks
- We are planning on starting on Fri 19<sup>th</sup> with a different distribution day – from the Snoqualmie Valley Food Bank b/c it is centralized and we will be at Fall City Elementary School
- Community – Si View is doing a food and fund drive – kick off next week
- School district will be doing a “Go Fund Me Food Drive”

**Update from Helping Hands**

- Helping Hands – more request coming in every day
- Community has been responding and rallying behind us to provide funding

- From Trissa with SSVS : Is anyone applying for KC COVID Community Response Fund? Looking for folks to collaborate with in regards to providing in-language technical assistance to Spanish speaking Sno Valley residents (ie; getting help with navigating unemployment, health services, and other support systems).

#### **Update from Hopelink (Carnation)**

- Still have funding for financial services
- Food bank still open
- All services are up and running just over the phone
- We are available funding wise for the time being
- The process and response time is – client will have a conversation with Haley to determine qualification. If they qualify, Haley will set up a longer appointment. Could take up to a few weeks to have the call with Haley. We are back logged and in the process of working through that. Once the client is in the system, it is now between Hopelink and the landlord, rather than the tenant

#### **Question about Rental Assistance through Hopelink**

##### **Who do clients call for rental assistance?**

- If the client is established in the Valley they would call the Carnation Hopelink, Bellevue clients would call the Bellevue location.
- Each Hopelink office has their own budget
